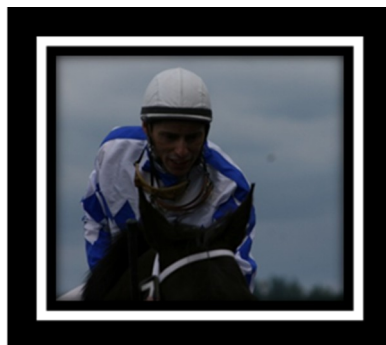
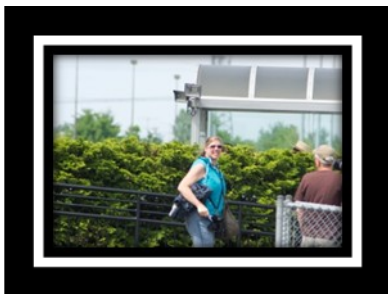

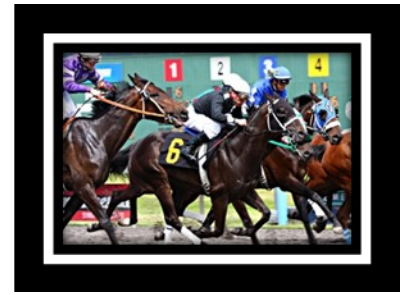


There are always interesting subjects to photograph at Emerald Downs and this day was no exception. Ladies in their finery (Sonya), Jockeys intent on the race (Harvey).
