AURORA 1 BY SHANE ELEN

"The Aurora shot was taken around 2.30am on the morning of July 15th using a D700 and Nikkor 17-35mm f/2.8, set at 20mm, f/2.8 , 1/15s and ISO800. This type of shot is best taken from a "dark-sky" site, the nearest being around 100 miles away. So given that the "weather" odds were stacked against capturing an aurora image that night, a closer urban location was selected. Fortunately, pollution on the horizon from the fires in Asia, along with low distant clouds in the North, helped in suppressing light pollution from the urban areas."

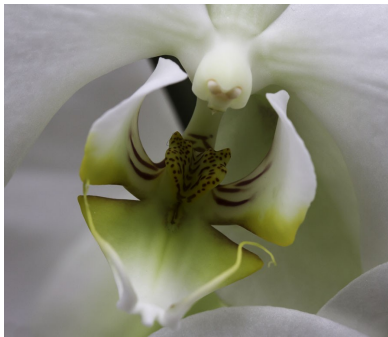

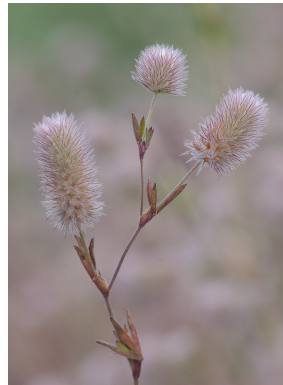

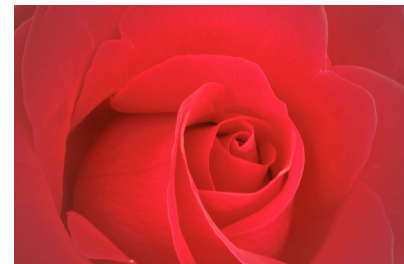
